**Sub: Permission matter of Dr.Yadubir Singh Sinha Homoeopathic Medical College and Hospital, Bakarganj, Laheriasarai, Darbhanga, Bihar for starting UG (BHMS) course with 50 seats for the academic year 2022-23- reg.**

Sir,

As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 Performa and all the relevant documents submitted by your college were examined as per the existing regulations.

2. The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for student intake in Under Graduate (BHMS) course with student intake of 50 seats for the academic year 2022-23.

3. On scrutiny and careful consideration of your documents and further observations of the Board, College was inspected on 21/11/2022 and as per the report, the following shortfalls needs to be addressed for granting permission for AY 2022-23:

i. **Collegiate hospital:**

**IPD:** Only few patients (6 in no.) were available in all wards.

**OPD:** OPD figures are not as per requirement of MSR.

ii. **College:**

Teaching Faculty: Dr. Ram Prakash Chaurasia working as Assistant Professor in Department of Anatomy is not eligible as he has joined as a Lecturer on 31/07/2008 and is having only Diploma in Homoeopathy against the requirement of BHMS Degree, as per regulation in force in 2008.

4. College has to take corrective measures in time bound manner to fulfill the above requirements for conducting under graduate (BHMS) course in Homoeopathy.

5. After considering the provisions of NCH Act, 2020 and its relevant regulations, **conditional permission of the Medical Assessment and Rating Board is granted to Dr.Yadubir Singh Sinha Homoeopathic Medical College and Hospital, Bakarganj, Laheriasarai, Darbhanga, Bihar with 50 seats in UG (BHMS) course for the academic year 2022-23.** The Principal is directed to fulfill the deficiencies within three months and an undertaking from the controlling authority of the college may be submitted in this regard to the Medical Assessment Board within a period of one week.


6. As per section no. 43 of the NCH Act 2020, vide letter no. Y-11011/4/2022-EP-III dated 14/10/2022, Central Govt. has taken a policy decision that all admission shall be through NEET only with qualifying marks 50 percentile. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed only.

7. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All India Quota. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.

8. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counselling of seats under All India Quota shall be conducted by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed


9. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
