Sir,

Dr. Yadubir Singh Sinha Homoeopathic Medical College and Hospital Bakarganj Laheriasarai, Darbhanga, Bihar 846002, established in 1995 has applied for permission for sanction of UG (BHMS) course with 50 seats for the academic year 2024-25. The College has submitted the Part I information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board have examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the application, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements:

a) Miscellaneous

- College has not enabled the Adhaar Enabled Biometric Attendance system (AEBAS) The same may be implemented in one month time
- Form 16 are not from Traces Portal. Copy of Form 16 of all Teaching faculties may be submitted for verification.

INSPECTION REMARKS

- Visiting physician were not available in OPD's during the day of visit.
- No qualified Pharmacist was available and the available stock of medicine in OPD was less and not properly arranged and dispensed.
- In Radiology Department no Radiologist was available and the technician did't have any personal protective equipment.
- Qualified Nursing staff was not available.

Considering the above observations and facilities available, Medical assessment and Rating board has decided to issue **Conditional Permission to of Dr. Yadubir Singh Sinha Homoeopathic Medical College and Hospital Bakarganj Laheriasarai, Darbhanga, Bihar 846002, with intake capacity of 50 seats in UG for BHMS course during A.Y 2024-25.**

All deficiencies noticed shall be rectified within a period one month and compliance report shall be submitted for verification.

All admissions shall be made for NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the intake capacity of 50 UG seats shall be treated as All India Quota .The counseling for seats under All India Quota shall be conducted by respective counseling authority as designated by Central Government /NCH for the A.Y 2024-25 and

counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of the State/UT.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 any time during the academic year.
