Sir,

Dr. Yadubir Singh Sinha Homoeopathic Medical College and Hospital, Bakerganj, Laheriasarai, Darbhanga –846002 Bihar with 50 Seats in Undergraduate (BHMS) Course for the Academic year 2025-26 has submitted an application for the permission for sanction of UG BHMS Course with 50 seats during the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH has conducted an Inspection on **06/05/2025 & 07/05/2025 followed by an opportunity of hearing on 12/06/2025**. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

- A. Teaching faculty:** - A total of 37 total UG faculty are available against the requirement of 40. It is observed that there is a deficiency of 05 teaching staff as per cadre wise requirement of MES 2024. The following are the details.
- In the Department of Homoeopathic Repertory & Case Taking** - Assistant Professor is not available.
 - In the Department of Pharmacy:** Associate Professor/professor is not available.
 - In the Department of Surgery, Community Medicine, Research Methodology & Biostatistics and Gynecology & Obstetrics:** - Associate Professor are not available.

As evident from the above statement, a total number of 03 UG teachers are deficient against the requirement of 40+1 for 50 seats UG college (As specified in MES,2024). Pursuant to F.No.:3-2/MARBH/NCH/2025-26/162-169 dated- 16/04/2025 issued by MARBH, a college can avail 15% relaxation against the required number of teachers for Academic Year 2025-26 only. However, such a relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

B. Teaching Departments: -

- In the Department of Forensic Medicine & Toxicology: -**
 - Bullets, Pistol bullet, Revolver bullet, Rifle bullet, Shotgun cartridge are not available.
 - Short gun cartridge, Comparison microscope for fingerprint -not available.
- In the Department of Surgery:** -X-Ray of intestinal obstruction, Sinusitis, OA Knee, Spondylosis and Spondylolisthesis are not available.
- In the Department of Community Medicine, Research Methodology & Biostatistics:** a Statistical assistant is not available.
- Department of yoga for health promotion:** Yoga Instructors are appointed but not having an required degree & registration as per MES 2024.

C. Hospital functioning: -X-ray is available but AERB license is not obtained.

D. Hospital staff: - General Physician (Emergency medicine and critical care) is not available.

E. Miscellaneous: -

- a) NABL accreditation for clinical laboratories is not available.
- b) Salary is not as per MES 2024.
- c) The college has applied for registration process at AEBAS portal.

2. Considering the above observations during inspection and hearing, MARBH has decided to issue Conditional Permission to Dr. Yadubir Singh Sinha Homoeopathic Medical College and Hospital, Bakerganj, Laheriasarai, Darbhanga -846002, Bihar with 50 Seats in Undergraduate (BHMS) Course for the Academic year 2025-26 on the basis of following conditions: -

- a) Deficient teaching faculty should be appointed.
- b) Salary should be as per MES 2024.
- c) The college should start marking attendance on AEBAS portal.
- d) General Physician should be as full-time faculty.
- e) AERB license should be obtained.
- f) Departmental deficiencies should be rectified.


3. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted UG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

5. All deficiencies mentioned at point 2 shall be rectified within a period of one month and the compliance report shall be submitted for verification, failing which permission for the academic year 2025-26 may be withdrawn.
